STREET LIGHTING SERVICE

Availability

Available to municipal corporations and other organizations qualifying for street lighting service. This service is subject to the Cooperative's rules and regulations.

Type of Service

Single-phase, 120/240 volts, 60 cycle alternating current.

Application

The consumer shall construct, maintain and operate the system. Lamps to be controlled by timing devices or photoelectric units to provide for service from dusk until dawn.

Monthly Rate

The monthly rate shall be as follows, based on estimated average monthly usage for unmetered lights:

STREET LIGHTING SERVICE

Tax Adjustment

The Cooperative is authorized to collect and pass on, by adding to the bill to the consumer, the applicable proportionate part of any taxes or government impositions which are or may in the future be assessed on the basis of the gross revenues of the Cooperative and/or the price or revenue from the electric energy or service sold and/or the volume of energy purchased for sale and/or sold hereunder.

Purchased Power Cost Adjustment

The Cooperative shall, if purchased power cost is increased or decreased above or below the base purchased power cost of \$0.066160 per kWh sold, flow through such increases or decreases to all classes of consumers in accordance with NMPRC Rule No. 550.

Terms of Payment

Billings made under this rate will be due and payable upon receipt and past due fifteen (15) days from the date the bill is mailed. Service will be subject to disconnect in accordance with the Cooperative's collection policy.

Renewable Energy Rider

The Cooperative shall add to its bill a Renewable Energy Rider in the amount set forth in its separate Rate Rider No. 1.

Other Charges

Other charges may be applicable subject to approval by the New Mexico Public Regulation Commission.
